Article (6) Area of state units of state:

- 1. The state units of the party will be formed according to the state and centrally included areas mentioned in the first list of the Indian Constitution
- 2. State units will have their headquarters in the capital of the respective state union territory.

Article (7) Tonure:

Each conference, every executive, every committee and office bearers will have a term of 4 years

Article (8) Election process and nomination of members:

All the top level committees and representative bodies of the party each executive, each committee will be formed through a democratic election process. And till the time of election of such bodies, their nomination will be for a maximum period of one year. And so Namaakn, may not be more than one third of the total number of committee / body.

The initial conference will be on the eve of the 10th of January on the initiative of active members of the Executive of the Legislative Assembly. A special committee on amendments regarding the chairman of the initial than member Vitapurten will be formed.

Each ward of the Nagar Panchayat will be considered as a preliminary committee.

Article (10) Assembly Constituencies Conference and Executive:

Within the foundation of the Legislative Assembly area which includes the Nagar Panchayat, each active member shall be a member of the Assembly Constituency.

The party, that in the residence of the party active members and bind the constituency MLA chairman of Zila Panchayat president Kshetra Panchayat, District Cooperative Bank and Director of the apex co-operative institutions shall be ex-officio members of the Assembly Constituency. It is mandatory for ex-officio members to be active members of the party. It will be necessary for all levels of representatives to be active members. The Chairman shall nominate one of the members of the Executive a Vice-Chairman, and a General Secretary, three Secretaries and a Treasurer.

The Chairman of the Legislative Assembly Area Executive shall call a meeting of the Executive at least once in a month.

Article (11) District Conference and District Executive:

The District Conference will have the following members:

1. Representatives elected for the District Conference by the Assembly Constituency Conferences and Municipalities having less than three lakh population.
2. All the present and former MPs and MLAs of the party of the district, president and members of the District Panchayat, the president of the district. All the current and former MPs and MLAs of the party the president and members of the District Panchayat, the President of the District Cooperative Bank, the President of the District Cooperative Union, the President, the Area President. The president and directors of the panchayat and the top cooperative institutions of the state and the Speaker of the Legislative Assembly will be ex-officio members of the district conference provided they are active members of the party. All will be ex-officio members of the District Executive.
